Inviting online tenders from approved contractor/firms of appropriate valid class (C & D) registered with HPPWD/CPWD/IPH/HIMUDA/MES/HPSEB are hereby invited on behalf of Himfed

The tender documents can be downloaded from website <https://hptenders.gov.in> and cost of form and earnest money thereof as mentioned below per tender form shall have to be deposited in the shape of Bank Draft/NEFT/FDR duly pledged in favour of Managing Director, Himfed, Shimla -3 payable at any scheduled bank at Shimla or directly in the bank account mentioned hereunder or through /NEFT in Federation s Current Account No.10835924452 with State Bank Of India, Branch at The Mall, Shimla (IFSc Code No. SBIN0000718) and proof thereof should be uploaded along with **Technical Bid** of the tender documents on top. In case the payment of earnest money and cost of tender documents is to be made by demand draft the instrument must reach the office of Managing Director by **27.12.2018 up to 5:00 PM** so that the same is encashed, failing which the tender will not be considered. The earnest money and cost of documents will not be accepted in the shape of cheques.

Instructions for E-Tendering

2. Entire tender process will be carried out online through above mentioned website. Tenderers are advised to procure E-Token/Digital Signing Certificate from suitable vendors or from any authorized agency.
3. Before submission of online bids, bidders must ensure that scanned copies of all necessary documents in single PDF have been uploaded with the bid.
4. Tenderers are advised to check/see website <https://hptenders.gov.in> regularly to check for any amendment/corrigendum in the tender document. All subsequent notifications/amendments/notices shall be published on the aforesaid website only.



If the date fixed for the opening of the tender is declared a holiday, the tenders shall be opened on the next working day at the same time as fixed for the original date for this purpose.

- b. **Financial Bid:** It shall contain financial bid/BOQ uploaded in .xls format which will be available for bidders on website <https://hptenders.gov.in>. The financial bid/BOQ will not be accepted in physical form.
