The earnest money and cost of documents will not be accepted in the shape of cheques.

- 1 The Managing Director reserves the right to cancel the tender without assigning any reason.
- 2 The work shall to be completed within Two Months after start of awarded work.
- 3 The contractor must produce valid registration.
- 4 The tenders of those contractors who do not deposit the earnest money in the prescribed manners will summarily be rejected.
- 5 The contractor has to arrange dumping site on his own risk and cost.
- 6 5% security will be deducted from each payment and will be released after six month as defect liability from date of completion of work.
- 7 Income Tax, CGST and SGST @ 1% each, 1% Labour Cess, Royalty and other Taxes as per prevailing rates will be deducted.
- 8 The work will be carried out as per HPPWD specifications.
- 9 The conditional tenders will be rejected.
- 10 The rates **not quoted** shall be treated as item to be executed **FREE OF COST** so ensure that all rates are quoted.
